## **CONCEPT NOTE**

The International Federation of Social Workers (IFSW) released a global definition of Social Work in 2014, which states that "social work profession promotes social change, problem-solving in human relationships and the empowerment and liberation of people to enhance well-being. Utilizing theories of human behavior and social systems, social work intervenes at the points where people interact with their environments. Principles of human rights and social justice are fundamental to social work." This definition places a focus on the fundamental ideas and purposes of professional Social Work. It draws attention to the profession's role in bringing about constructive change, dealing with social issues, and empowering people and communities. Social workers intervene and provide assistance for people in a variety of situations by building on their knowledge of social processes and human behavior. Social work practice is seen to be built on the core ideas of social justice and human rights.

Many nations around the world recognize social work as a profession, while the particular recognition and requirements can change. Social work is recognized and practiced in many nations, including the United States, Canada, the United Kingdom, Australia, Germany, Sweden, Brazil, South Africa, and many others. Social work in India can be traced back to the pre-independence era when philanthropic efforts were made by individuals and organizations to address social issues. After India gained independence in 1947, social work gained more recognition and prominence. The government established institutions and programs aimed at addressing social welfare and development issues. Social work education in India is offered at various levels, including diploma, undergraduate (Bachelor of Social Work), postgraduate (Master of Social Work), and doctoral programs. Several universities and colleges offer social work courses across the country. The profession of social work in India is supported by professional associations such as the National Association of Professional Social Workers in India (NAPSWI) and the Indian Council of Social Welfare (ICSW).
