Such an international relational perspective also acknowledges the diversity and complexity of human experiences and identities, and the need to respect and empower the voices and agencies of the people affected in similar and yet, significantly varying ways. Hence since a perspective can help social workers to:

A) Develop a global and critical awareness of the historical, political, economic, cultural and other factors that shape the causes and consequences of social problems, and the potential and limitations of social policies and interventions;

B) Network with other social workers and professionals from different regions, disciplines to exchange knowledge, skills and resources and to advocate for beneficial change in varying societies, thus co-creating solutions that are culturally appropriate, participatory and sustainable.

Therefore, the theme of Social Work and International relations in a changing world offers challenges and opportunities for the social work profession. The social work profession can contribute to the development of a more peaceful, inclusive, and sustainable world in which the values and principles of human rights, social solidarity and global citizenship are fostered.

given sub themes of this conference are invited.

Following are the general guidelines given for the paper presenters :

A. Building Global Peace and Amity:

When Social work professionals focus on creating a world that respects and celebrates human dignity and diversity, they can foster global peace and amity in our world. Papers could focus on sharing experiences of, and reflections on, peace building, especially those that offer a critical analysis that helps to identify causes and drivers of violence, injustice, and inequality; or that showcase an ethical and cultural sensitivity to respond to complex and dynamic situations.

B. Respecting Cultural Diversities:

This theme highlights the importance of cultural and ethnic identities in shaping social dynamics and international relations. It addresses challenges arising from plural cultural interactions. The policies for diverse communities. Emphasis is placed on fostering sensitivity, inclusion, and mutual respect through social work. The role of institutions in promoting cultural harmony is also central. Papers should explore innovative practices and policies that embrace diversity and equity.

C:Fostering Equality for Sustainable Development and Ecological Justice

In today's global landscape, social, economic, and environmental challenges disproportionately impact marginalized communities. While international policies often claim to support development and sustainability, the active representation of least developed and developing countries in global discussions remains inadequate. Vulnerable groups continue to face injustices related to resource extraction, hazardous waste disposal, and limited access to governance. An intervention model that includes inclusive governance, education and resource justice.

D. Creating Inclusion in a Diverse World:

Marginalized and vulnerable groups such as women, girls, persons with disability, LGBTQIA+, religious, racial, and ethnic minorities, as well as children in vulnerable situations, are at greater risk due to social inequalities, injustice, and global crises, such as the COVID-19 pandemic. Inclusion is founded on normalization and the principles of affirmative action, equality, human rights, and quality of life, as well as promoting inclusion for all. The focus is on the challenges social workers face in this context, as well as their initiatives, innovative strategies, and interventions adopted by them.

E. Enhancing Couples, Family and Social Relationships:

Changes in contexts related to diversities of culture, geography and systemic factors influence the ways in which family forms, interactions and relationships are enacted, navigated and transacted. This theme pertains to interactions, relationships and consequences of global and local changes that influence families both within and outside. We welcome submissions that contribute to conceptual or theoretical expansion and innovative interventions that enhance wellbeing.

F. Challenges for Social Work in an Increasingly Digitalized World:

Paper presenters may focus on the transformative potential or destructive tendencies / ethical dilemmas of using technology and AI in the field of social work. How can social workers be better prepared to deal with the interface between AI and social work can be the focus of this subtheme. Further, innovative interventions and strategies used by social workers using AI can also be presented under this sub theme.

G. Nurturing Children, Global Greying and Social Security:

The sub-theme "Nurturing Children, Global Greying and Social Security" explores the dual demographic challenge facing the world today—an ageing population alongside declining birth rates, compounded by global shifts in family dynamics, mobility, and environmental instability. It highlights how social workers are central to navigating this complex landscape.

Abstract Submission Guidelines

- Abstract abstracts must be focused on a specific Theme and Sub Theme.
- > Use Times New Roman 12-point font, double spaced.
- > Abstract title limited to 15 / 20 words in UPPER CASE.
- ➢ Abstract text − Up to 500 words
- Presenting author's contact details (should be the same as the submitting author so that the presenting author receives the correspondence about the abstract)

Submission Rules for Papers:

- > Paper should be in double spaces.
- The maximum length of the submission is 20 pages (including title page and all figures, tables, appendices, and references.) - limited to 5,000 words
- The entire paper submission (title page in title case, abstract (500 words), main text, figures, graphs, tables, references, etc.) must be in Microsoft Word format (.doc / .docx)
- > Numbering the pages in the document is essential.
- Submitted papers must NOT have been previously presented, scheduled for presentation, published, or accepted for publication by any other source (journal, publisher or any other organization).
- No changes in the paper title, abstract, authorship, nor submitted document can occur AFTER the paper submission deadline.
- Make sure that the file or document uploaded is virus-free before submitting.
- Abstracts and Full papers may be sent to indiaconference25@gmail.com
- Participants must register prior to the registration deadline in order to present their papers. All authors must register.
