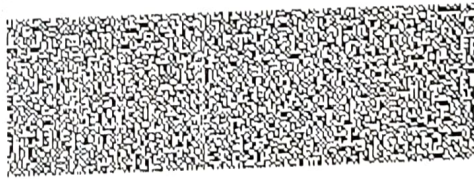

WHEREAS the College is desirous to undertake purchase of IBM SPSS Software Base v28.0 + 14 Modules for 10 Users Perpetual License with One Year AMC. Tender No- 2021_RUSA_748549_1 Vide Acceptance Letter Ref/cswnn/soft/21-22/05 Dated: 11-01-2022 worth Rs.10,88,808/- (including 18% GST) (Rupees Ten Lac Eighty Eight Thousand Eight Hundred Eight Only) Systems shall be ready as per System requirement of said Software by the College of Social Work Nirmala-Niketan as per submitted in Tender.

WHEREAS the contractor/supplier has agreed to execute upon and subject to the condition set forth herein (herein after referred to as the said conditions) the work shown upon the said priced schedule of quantities at the respective rates mentioned to the priced schedule of quantities.
