Introduction

• Introduction by Divija (MSW-2): The event began with Divija from MSW-2 delivering a warm introduction, setting the tone for the session.

Presentation by Prakriti Trust

<u>1. Fatima from Prakriti Trust:</u>

- Fatima introduced Prakriti Trust, which has been working for over 30 years in child protection and human trafficking prevention and rescue.
- She discussed the trust's collaboration with Young India Unchanged and the Maharashtra Prevention of Women initiative, highlighting their work in Nagpur and Mumbai, and alliances with organizations like Pratham and Yuva Rural.
- Fatima engaged with the students, discussing Mumbai's fame, places, food, and other aspects.

2. Meena from Prakriti Trust:

- Meena then took over to explain the darker side of Mumbai, emphasizing its notoriety for crime.
- She highlighted that Maharashtra registered the highest number of human trafficking cases in 2022, with 793 females and 12 males rescued from human trafficking and sexual violence.
- Meena presented a video showcasing the alarming statistics on sexual violence and molestation, revealing that one girl is sexually abused every 20 minutes and 96% of women face public molestation. The video also covered cyber crime statistics, with 5,562 cases registered in 2021.

Human Trafficking Awareness

3. Fatima's Explanation on Human Trafficking:

- Fatima elaborated on the making of the video, emphasizing the importance of awareness and volunteer involvement.
- She discussed how human trafficking is a process involving act, means, and purpose.
- Fatima engaged students in identifying human trafficking, explaining that taking someone without consent for purposes like sexual exploitation or organ harvesting is a key indicator.

4. Student Interaction:

- Students discussed the importance of recognizing means and purpose in human trafficking.
- Fatima shared case studies, including a minor and a cyber crime case, illustrating different forms of human trafficking and exploitation.

Advocacy and Prevention

5.Sakshi from Prakriti Trust:

- Sakshi highlighted the increasing involvement of youth in both experiencing and perpetrating crimes.
- she emphasized the need for advocacy and policy-making to address these issues.

6. Ma'am's Explanation:

- Ma'am explained how Young India Unchanged provides a platform for connecting with police and organizations, advocating for victims, and preventing perpetrators from causing harm.
- She encouraged students to amplify the movement and participate in policy-making.

7. Interactive Activity:

- A fun activity was conducted involving 10 female and 2 male volunteers. The activity simulated a protective circle with foxes and goats, emphasizing planning and protection strategies.
- Ma'am explained the significance of the activity, highlighting how the second attempt took more time for the foxes due to better planning and coordination by the goats.
