Some important events/activities that were coordinated included the Workshop on Dying Declaration in cases of domestic violence against women; Shelter Homes in Mumbai, "Men's involvement in Women's Issues" at the World Social Forum, Mumbai (January 2004, with 200 participants), paper presentation at the International Conference on "Male Preference and Bride Burning in India", New Delhi. A major learning experience was having the valuable opportunity to co-author the research "Content Analysis of 72 Dowry Death Cases" handled by Sakhya, A Field Action Project of the College of Social Work, Nirmala Niketan, in 2005 and completing the Memograph on the Leadership Training Programme conducted by Sakhya at the Dockyard Road Community in 2004.
